Well, Berkeley Park has had to deal with a burglary threat over the last few weeks. Homes on Tallulah were burglarized, and a 6'-2" man known as a burglary suspect has been seen walking from the Castlegate and Atlantic Envelope Site towards our neighborhood, probably up to no good we suspect.

What can we do to thwart this latest problem? A few things come to mind:

1. Alert 911 if you see anybody suspicious in our neighborhood. If the 6'-2" suspect is seen call 911 and report that you have seen a burglary suspect in the neighborhood. They should come quickly.

2. Keep an eye on foot traffic around Castlegate and Atlantic Envelope site. Reports have been that temporary shelters have been built on these sites. If you see these shelters please report them to the police so that they can follow up. If you see any suspicious activity call 911.

3. Let your neighbors know when you are out of town. Hide valuables out of plain site. Lock windows and deadbolt

doors. Leave lights on in the house. Have your neighbor pick up your mail if you go out of town for an extended period of time.

These are a few things that can go a long way in having a safer neighborhood. We actually do pretty well considering our location so close to downtown, but a little preventive care can never hurt!

Let your neighbors know when you go out of town. These are the little things that go a long way in reducing crime in our neighborhood.

Franz and Bob have presented a plan for the corner of Tallulah and Antone in which a 5-unit town home development will be constructed. ### August Gardening Tips from Pike Family Nurseries

The hottest, driest month of the year is upon us. It's hard to imagine spending the afternoon working out in the hot sun with the mosquitoes, so why not find a nice shade tree and grab yourself a cold drink and remember that hints of fall are just six weeks away! Until September does arrive, here are some tips for gardening during the month of August:

- During water restrictions, don't water heavily every time watering is allowed. Annuals can go several days between waterings if they get a good soaking (either by nature or you) once a week.
- Avoid digging in your flower beds. Disturbing the soil in the hot months can damage surface roots, reducing the plants ability to take in water efficiently.
- Don't panic at the sight of wilted leaves. The roots cannot keep up with the water requirements of the leaves in the hot sun, so as long as the soil is moist the plants should perk back up by late afternoon or early evening.
- Check the soil in container plants every evening. Their water supply is more limited and may need a shower each day.
- Keep your garden attractive by removing dried out,

dead leaves & flowers. Mulch any empty areas to deter weed growth.

- Be careful not to over water. Plants often wilt because of a lack of oxygen, so check the soil moisture around the stem before grabbing the hose.

- Shrubs should be watered deeply once a week. Many plants, including azaleas, camellias and rhododendrons are starting buds for next season's blooms at this time.

- Avoid excess evaporation when watering your lawn by using a sprinkler that produces large drops of water instead of a fine mist and remember to water early to allow the grass to "drink" all day long.

- A last blast of fertilizer should be applied to warm season grasses (Bermuda, St. Augustine or zoysia), but be sure to irrigate immediately to carry nutrients down to the roots and wash any residue off plants.

- Plant late-summer/fall-blooming bulbs like spider lilies, crocus, meadow saffrons and autumn daffodils.

- Plan, plan, plan. August is a good month to evaluate your garden and make a list of spring bulbs, perennials, shrubs, trees, ornamental grasses, vines and ground covers you'd like to add once the weather begins to cool down.

## SPECIAL TOPICS

A few people in the neighborhood (Verner and Antone) have reported finding dead blue jays possibly infected with the West Nile Virus. Blue Jays and Crows seem to be most susceptible to WNV, so it's imperative that these birds be picked up immediately (within 24 hours) to be tested for the virus.

It's the best way for them to track the disease in the area, and prevent it from spreading.

The Centers for Disease Control and Prevention issued advice to cities and counties all over the United States concerning the West Nile virus. People are urged to avoid mosquitoes and get rid of places that can hold standing, stagnant water because that's where mosquitoes breed.

Here are a few ways to prevent the likelihood of contracting the West Nile virus:

- \* Keep outdoor activity to a minimum. When outdoors, wear long pants and long sleeves.

- \* On exposed skin, use mosquito repellent that contains less than 30 percent DEET for adults and 10 percent DEET for children over age 1. Do not use DEET on infants.

- \* Eliminate standing water, prime breeding ground for mosquitoes. Empty old tires, barrels, planters and other objects that hold water.

- \* Clean gutters, flat roofs and air-conditioner drains frequently.

- \* Change the water in birdbaths, pools and animal dishes at least once a week.

- \* Repair screens on the entrances to homes and businesses.

- \* Keep grass and weeds mowed.

Can WNV affect my pets?

Dogs, cats and other small mammals do not generally become ill if infected with WNV. However, horses can become ill and even die. Check with your veterinarian about availability of a newly licensed equine vaccine for areas where WNV is prevalent.

### It is time to fix Atlanta's sewer problem

August 4, 2002 -- How would you like to pay nearly \$1,800 a year just to flush your toilet?

If you live in the city of Atlanta, that could be a painful scenario.

Why?

The City of Atlanta Sewer system stinks, literally. In fact, the city is in violation of the federal Clean Water Act. Experts estimate it will cost the city \$3 billion over the next 12 years to fix it, as required by a federal court order.

Historically, the cost of sewer repair has fallen upon the rate payers -- people who own property in the city. It doesn't take a genius to figure out that \$3 billion split among property owners is siphoning off their personal income too much -- nearly \$1,800 a year for the average homeowner. Businesses would find it almost cost prohibitive.

So what can we do?

Cities like Boston and San Diego have lobbied to get federal dollars to help them out, and they got it -- billions of dollars that we helped raise through federal taxes. So, that's why we're asking you to take action.

Write all of our Congressional representatives to "Get Atlanta the Money."

Sorting out this issue is extremely important NOW as Congressional budgets are fixed by October. And we don't want Atlanta to go down the drain.


